House Rules of the "Stellwerk" – Haus der Jugend

Whenever people come together, there are certain rules of dealing with each other. These house rules want to provide all visitors of the "Stellwerk" - Haus der Jugend some binding rules of conduct in order to ensure a pleasant together as possible in the house.

These house rules apply to the house and the associated outdoor facilities.

1. General:

- The "Stellwerk" Haus der Jugend is an institution of the municipality Herrsching am Ammersee and serves the open youth work.
- The "Stellwerk" Haus der Jugend is a shelter for its visitors.
- The "Stellwerk" Haus der Jugend is open to all young people from 12 to 21 years in exceptional cases, up to the age of 27.
- All visitors have equal rights irrespective of their age, sex or other characteristics.
- Young people under the age of 18 are subject to the laws protecting youth in public, with a reprint of the most important provisions in the "Stellwerk" - Haus der Jugend.
- Party political activities, third-party commercial events or commercial promotional events are not allowed.
- Events of cultural, ecological or democratic youth education are permitted.
- Gambling and gambling for money is not allowed.
- Compared with underage visitors, there is no duty of supervision on the part of the full-time staff of the municipal youth work.
- The full-time employees of the municipal youth work exercise the house right for the municipality Herrsching.

2. Opening hours:

The "Stellwerk" – Haus der Jugend is open on the following days:

Tuesday: 3-8 pmWednesday: 3-8 pmThursday: 3-8 pmFriday: 2-8 pm

The current opening hours are both on our website <u>www.stellwerk-herrsching.de</u> announced as well as attached to the front door for all visible. Changes are reserved and will be announced as well

3. Use of the rooms in the "Stellwerk" – Haus der Jugend, liability and damage:

- Every visitor is responsible for the preservation of the rooms and the entire interior design the rooms and the inventory are to be treated with care.
- In the event of damage to the house or its inventory, the person responsible must immediately report this to a full-time employee.
- In the event of damage, the person causing the damage must replace the damaged object. The compensation can be made in exceptional cases in controlled work assignments.
- The visitors themselves are responsible for the resulting waste and its disposal in our rubbish bins.

- The right to one's own image must be preserved. Photo, video and sound recordings are made only with mutual consent. Photos for public relations are announced and treated in accordance with the General Data Protection Regulation.
- The stay in the "Stellwerk" Haus der Jugend and the use of the furnishings is at your own risk.

4. Behavior of the visitors:

- Peace and respect: We value respectful interaction and a friendly atmosphere, free from violence, harassment and insults.
- For this reason, all visitors have the same rights and obligations regardless of their life situation, nationality, gender, sexual orientation, religion or other characteristics.
- We do not tolerate extremist, nationalist, anti-democratic and racist utterances or actions, or any religious intolerance, proselytizing, sexist utterances or actions. Long live the diversity!
- The volume of the music should be adjusted so that conversations with each other are
 possible. Especially with the windows open, the music is at room volume. Especially
 when leaving the house and in the immediate vicinity unnecessary noise should be
 avoided. Registrations have to be announced at an early stage in the neighborhood as
 well.

5. Protection of minors – alcohol consumption and smoking:

- Beer is served in a controlled manner during the opening hours from 6 pm to visitors who have completed at least the age of 16 and can prove this accordingly.
- The consumption of spirits is generally forbidden to visitors over 18 years of age.
- Bringing alcohol and mixed drinks is prohibited.
- Access in an alcoholic state may be prohibited.
- Smoking is generally prohibited in the rooms and on the premises of the "Stellwerk" Haus der Jugend.

6. Drugs and weapons:

- Taking, consuming and trafficking of drugs and intoxicants on the grounds of the "Stellwerk" Haus der Jugend is prohibited.
- The bringing or leading of weapons of any kind is prohibited.
- As a consequence of a violation threatening permanent house ban and police report.

7. Compliance with the house rules:

- Every visitor recognizes the house rules by entering the "Stellwerk" Haus der Jugend and behaves according to their wishes.
- Visitors who oppose the applicable regulations may be temporarily or permanently prohibited from access.
- Applicable regulations include statutory provisions, the house rules and rules and instructions adopted by the municipality, the local council and the team of municipal youth work.
- A house ban applies to the "Stellwerk" Haus der Jugend and its associated outdoor area.
